

Dear Sidney Chelsky:

On behalf of the Honourable Ahmed Hussen, Minister of Families, Children and Social Development, I am responding to your email which were forwarded by the Office of the Prime Minister, the Right Honourable Justin Trudeau on May 12, 2020. You wrote concerning he Canada Emergency Commercial Rental Assistance (CECRA) program. Please accept my sincere apologies for the delayed reply.

As you know, included in the support under the <u>Government of Canada's COVID-19 Economic</u> <u>Response Plan</u> is the <u>CECRA</u> program. In partnership with all provinces and territories, the federal government is making funds available to support small businesses to provide relief for those that have either been forced to close or have had their revenues severely impacted by the pandemic. The CECRA program for small businesses is a forgivable loan to qualified commercial property owners who have entered into rent reduction arrangements with their eligible impacted small business tenants, including not for profits and charities. The program is targeted at small business tenants that pay less than \$50,000 per month in rent, generate no more than \$20 million in gross annual revenues and are experiencing at least a 70 per cent drop in preCOVID-19 revenues.

It is important for landlords to know that under the CECRA program, they will still collect a portion of their gross rent covering April to August 2020, and the loan will be forgiven if they comply with all applicable programs terms and conditions, including to not recover forgiven rent amounts from their impacted tenants when the program is over. I would also like to point out that properties with or without a mortgage may be eligible under this program.

Since the start of the pandemic, all orders of government have been urging property owners to provide flexibility to tenants facing hardship in this uncertain time. Because most landlords depend on the success of their tenants, it is in their best interest to provide stability and financial support where possible.

We exhort all eligible property owners to participate in the CECRA program and are working hard to ensure that they understand the benefits, as it is designed to assist both property owners and their small business tenants.
